How long should I hold it and can I take money out early?

Recommended holding period: 7 years

The recommended holding period (RHP) has been calculated in line with the investment strategy of the Sub-Fund and the timeframe in which it is expected that it will be possible to achieve the investment objective of the Sub-Fund. This product may not be suitable for investors who plan to redeem their contract before the end of the recommended holding period.
