#### You are about to purchase a product that is not simple and may be difficult to understand.

### What is this product?

- **Type:** The product is a Sub-fund of Mediolanum Best Brands (the Fund), an open-ended umbrella Unit Trust established by Mediolanum International Funds Limited as a UCITS pursuant to the provisions of the UCITS Regulations and governed by Irish law.
- Term: This is an open ended fund with no maturity date.
- Objectives:
  - The Sub-Fund's objective is to achieve long term capital growth.
  - The Sub-Fund invests in global (including emerging market) equities (listed shares) and equity related securities in the infrastructure sector (such as energy, transport and telecommunications) either directly and/or indirectly (by investing in funds and/or derivatives).
  - The Sub-Fund invests mainly in funds which are selected following Manager evaluation of: investment team strength, underlying investment process quality, opportunity for future capital growth and ability to pay dividends.
  - The Sub-Fund may use financial derivative instruments (FDIs) whose performance is linked to that of underlying security(s) or asset class(es). Their use may be for efficient portfolio management, hedging and/or direct Investment purposes.
  - The Sub-Fund may enter into securities lending transactions.
  - The Sub-Fund is actively managed (meaning that the Manager has full discretion over the composition of the Sub-Fund's portfolio of assets) and is not managed with reference to any benchmark.
  - The Manager has flexibility to change the Sub-Fund's asset allocation (% of the portfolio invested in equities/FDIs etc) at any time and has discretion to select investments within each asset class.
  - The product is compatible with investors that can bear and/or afford to fully or partially lose the capital invested and are comfortable with no capital guarantee.
  - Income and gains generated by the unit class will be distributed periodically in the form of a dividend.
  - Units can be bought or sold on any business day from the Fund's Administrator.

# What are the risks and what could I get in return?

#### **Costs over Time**
