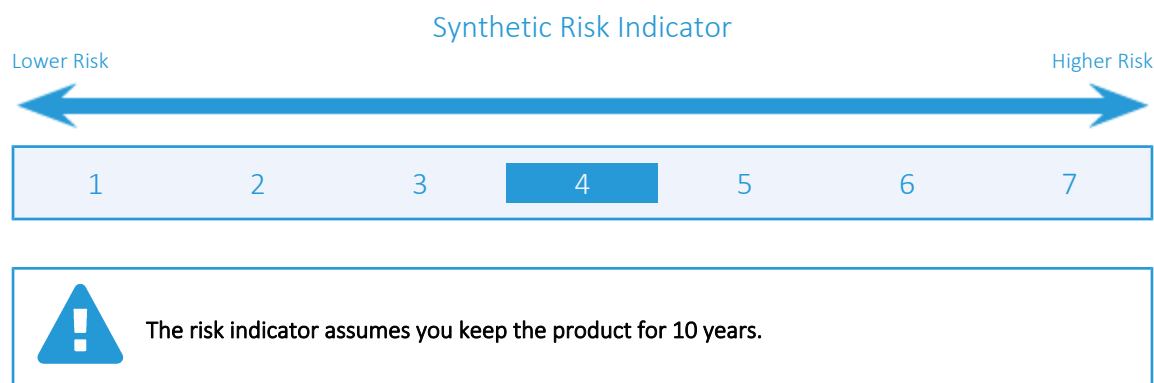

You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

- **Type:** The product is a Sub-fund of Challenge Funds (the Fund), an open-ended umbrella Unit Trust established by Mediolanum International Funds Limited as a UCITS pursuant to the provisions of the UCITS Regulations and governed by Irish law.
- **Term:** This is an open ended fund with no maturity date.
- **Objectives:**
 - The Sub-Fund's objective is to achieve long term capital growth.
 - The Sub-Fund invests in global (including emerging markets) equities (listed shares) and equity related securities focusing on the healthcare sector and healthcare related sectors either directly and/or indirectly (by investing in funds and/or derivatives).
 - The healthcare sectors include but are not limited to companies engaged in the research, design, development, manufacture, distribution, supply or sale of healthcare related products, services or devices including but not limited to those companies in pharmaceutical, biotechnology, medical technology and life sciences as well as healthcare providers and services companies.
 - The Sub-Fund may use financial derivative instruments (FDIs) whose performance is linked to that of underlying security(s) or asset class(es). Their use may be for efficient portfolio management, hedging and/or direct investment purposes.
 - The Sub-Fund may enter into securities lending transactions.
 - The Sub-Fund is actively managed (meaning that the Manager has full discretion over the composition of the Sub-Fund's portfolio of assets) and is not managed with reference to any benchmark.
 - The Manager has flexibility to change the Sub-Fund's asset allocation (% of the portfolio invested in equities/FDIs etc) at any time and has discretion to select investments within each asset class.
 - The product is compatible with investors that can bear and/or afford to fully or partially lose the capital invested and are comfortable with no capital guarantee.
 - Income and gains generated by the unit class will be reinvested. No dividend will be paid.
 - Units can be bought or sold on any business day from the Fund's Administrator.

What are the risks and what could I get in return?



- The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.
- We have classified this product as 4 out of 7, which is a medium risk class.
- This rates the potential losses from future performance at a medium level, and poor market conditions are very unlikely to impact the capacity of the issuer to pay you.

Recommended holding period: 10 years

We recommend that you hold the investment at least until the end of the recommended holding period in order to fulfil the objectives of this product.
